## Summary of CV

PhD in Human Rights from the University of Palermo, Italy. **Tenured Scientist** at the Institute of Philosophy of the National Spanish Research Council. Previously, **Ramón y Cajal** Research Fellow at the same Institute. **Principal Investigator of 7 competitive projects** on gender, intersectionality, migration and human rights. Expert in intersectionality. Interdisciplinary research covering **Philosophy of Law, Social Philosophy, Socio-Legal Studies, Law & Society, Gender and Politics, Public Policy Implementation, Intersectionality, International Migration Studies, and Citizenship Studies.**

The common threads of my research have been human rights and intersectionality. The concepts of social justice, gender equality, cultural diversity, social identity and membership are key in my research.

My research addresses the social changes linked to recognition of gender equality and movement across borders in the globalized society. I inquire about how social structures and legal institutions shape individual and collective positioning, specifically focusing on the intersections of gender and migration.

I enrolled in the PhD program on **Human Rights** of the University of Palermo with a fellowship from the Italian Ministry of Education. During my doctoral research, I have been accepted as a Visiting Student at the University of California-Berkeley where I was later hired as a Staff Researcher at the Boalt Hall Law School. I analyzed the legislation regulating ritual interventions on female genitalia to show the limits of the dichotomy of feminism vs. multiculturalism discourse. The main theoretical outputs have been the introduction of the concepts “multicentered feminism” and “intersectional gender”. I received the International Award **Joven Investigador en Filosofía Jurídica y Social** from the Asociación Argentina de Filosofía del Derecho.

As a postdoctoral researcher, I obtained various fellowships and contracts on competitive basis: a fellowship from the Italian Ministry of Education to stay abroad and join the Department of Anthropology of the **University of California-Berkeley**; a contract to join the Department Diritto, Política e Societá of the **University of Palermo**; a **Jae-DOC** fellowship to join the **Centro de Ciencias Humanas y Sociales** of **CSIC**; a **García Pelayo** fellowship from the Spanish Ministry of Presidency to join the **Centro de Estudios Políticos y Constitucionales.**

My postdoctoral research focused on the **construction of social identity during migration.** I explored theoretical questions related to identity in multicultural societies, the effect of migration regimes in marginalizing migrants, and the relevance of law in the construction of social identity, membership and belonging. I worked on the conceptualization of intersectionality as a criterion to interpret multiple and interlocking discrimination that affects migrant women.

My more recent research focuses on **legal-political conceptualizations** and their **institutional and social effects**, especially in relation to citizenship/nationality, gender equality and intersectionality. I adopt a **discursive approach** that understands discourse as a social practice constituted



by institutions and structures that shape action. I pay attention to the positionality of law practitioners, their theoretical and practical knowledge, and the multiple meanings they display. This interdisciplinary research is located at the intersection of social theory, law, sociology and political sciences. I established long-standing collaborations with sociologists and political scientists that nurture my **interdisciplinary** approach.

In my studies focusing on the interpretations of the concept of gender, I inquire about the multiple meanings assigned to gender equality by implementing actors and the different **implications for the legal-institutional praxis**. The main outcome of this line of research is that disregarding the structural and intersectional dimensions of gender equality reproduces women's discrimination in more subtle and complex ways to dismantle.

Following a hermeneutic approach, my recent research on intersectionality is devoted to understanding the **construction of its meaning** in relation to other closely related legal-political concepts, like gender and diversity, especially in **judicial decisions** and **public policies** implementation. The goal of this line of research is to identify both existing obstacles and enabling factors to foster the doing of intersectionality.

In my ongoing research on the conceptions of citizenship, the analysis of the **judicial discourse** along with the **narratives** of those who apply to nationality are key to challenge the "emotional vs pragmatic" dichotomic framing of national belonging. The goal is to explore the nuanced meanings of membership and to contribute to the articulation of justice-oriented alternatives for the **era of international migration**.
